Kinard / Haag: Server slowness has been identified and resolved.

 Best guess is extra security scanning of accession detail pages due to DEV change related to website traffic. 10s of thousands of IP addresses visiting the PW.

Cyr: Working on Fieldbook data upload wizard.

- Is there interest in another Q&A on current use of Fieldbook, common challenges and workarounds? The latest Q&A on Fieldbook was held in September, 2024.
- Is there a list of sites that use Fieldbook? No, but NE9, NC7, DAV are trialing use (especially to collect photos)
- Ask to make Fieldbook a PGOC topic?
- Poll the GRIN-ALL email list asking about Fieldbook use and how field data is currently collected.

**PGOC is Virtual (Aug 4-5)** and is hosted in person at Geneva next year. Hosted this year by Ben and Claire Heinitz

**Kinard / Kothari**: Website access is best to be validated before access to the germplasm and associated information is granted for security reasons. Including filling out basic profile information (geography, affiliation, valid email, etc.).

- Need access to programmer who can update the PW to add email verification (and possibly two-factor authentication). CREATE Trac:
- Taxonomy information (not NPGS germplasm) may need to remain accessible without a login.
- Many USDA data-calls received by Kothari are related to GRIN-Global data sets.


