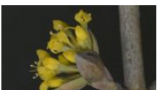

Name	Material or Method Used
NPGS.INACTIVE.DUPLICATE.PASSPORT	Accession was determined to be duplicate of an already existing accession. PASSPORT
NPGS.INACTIVE.DUPLICATE.PHENOTYPIC	Accession was determined to be duplicate of an already existing accession. PHENOTYPE
NPGS.INACTIVE.DUPLICATE.GENOTYPIC	Accession was determined to be duplicate of an already existing accession. GENOTYPE
NPGS.INACTIVE.NEVER-RECEIVED	Accession assigned a site identifier, but material was never received.
NPGS.INACTIVE.DEPLETED	Physical inventory was depleted.

Multiple distribution lot selection in the accession search on the PW:

Should the requestor be forced to pick one of the DI lots? Currently if you select items to go into the cart from the list, the system selects one to put in for you – you don't know which one until checkout. Do we add some text that says “if the cart icon has a +, there are different lots available for distribution, please look at the accession detail page to select the lot you wish to order”?

Old Business: Inactivation methods

No comments.

New Business: Multiple distribution inventories. (Todd R.)

- First chosen form type is SD. If no seed lot is available, it defaults to alphabetical selection.
- “+” Icon indicates multiple items are available.
- Marty suggested adding a priority form type field to the database so that the curator can indicate the default inventory form type when more than one form is available. (This field may need to be added to the Accession record.)
- Stacey suggested a second page or pop ups where the requestor must select the form type IF the cart icon has the plus. No items are added by default.
- “Non-viable” form type could be indicated with a new form type. SD is propagative and would go out internationally with an SMTA even if the germplasm is known to be dead.
- **We have NO PW developers so no major enhancements can be made at this time.**
- Suggestion to separate “+” accessions from single form type accessions during the checkout process. Program so that users must make a form type selection IN THE CART during the checkout process. This could be handled by separating different form types in the cart
- Add “web availability note” to search results table and maybe user cart table. This field can only be seen from the accession detail page. Most users do not see the note because they do not click into the accession detail page of every single requested accession.

Trac tickets to create:

1. PW user must select specific items when multiple inventory are available.
2. New form type for “non-viable” inventory forms that were propagative material but are now non-propagative (eg. inviable / dead / inert) by viability testing or treatment. “Non-viable material. For example, seeds that do not germinate but can be used for comparison studies.”
3. Add “web availability note” to search results table and maybe user cart table.

New business: Web cooperator note (Lisa T.)

- Web cooperator note is showing up in order request note field. This note field is also used by the NRR tool for NPGS-wide reviewers to indicate internal review notes.
- Legacy field that PW users used to be able to fill out pre 2019. PW user access was removed in the re-vamped PW. Now no internal or external user can find the field to fix it.
- DBMU cleaned up records and removed note from the web cooperator records (19,000+).

New business: NPGS Coffee Hour follow-up (Lisa B.)

- Fieldbook questionnaire: How is field data collected and where is it stored? Funding for the app was cut so Fieldbook currently has no planned updates.
